Dear Dr. Helstein, Dr. Gamble and Mr. Crow:

The Justice Centre for Constitutional Freedoms, the Society for Academic Freedom and Scholarship, and the Frontier Centre for Public Policy are sponsoring a debate on the question "Does 'Woke-ism' Threaten Academic Freedom?" at the Lethbridge Public Library on Saturday September 16, 2023 from 2:30-5:30 p.m. "Woke-ism" is a form of identity politics that has become totalitarian in nature, insisting that the "ways of knowing" of groups claiming to be oppressed be "respected" and "valued".

Three participants – Jonah Pickle (a neuroscience student at the University of Lethbridge), Paul Viminitz (a philosophy professor at the University of Lethbridge) and me – will be arguing that it does (see attached). To facilitate critical thinking and ensure that diverse viewpoints are explored, we are seeking three opponents to put forward the "no" position.

As the previous provost of the University of Lethbridge, Dr. Erasmus Okine, declined to provide space for my talk "How 'Woke-ism' Threatens Academic Freedom" that Dr. Viminitz organized on February 1, 2023, and because the University of Lethbridge has retained the legal firm Reynolds, Mirth, Richards & Farmer to fight the Charter challenge about the cancellation, I assume that Provost Helstein would put forward a similar position to Okine's (see attached).

Dr. Jay Gamble, an Instructor in the Department of English, was one of the most active opponents of my talk. On Twitter, Dr. Gamble congratulated community members for having "Drummed the fuck out on her ear" and expressed "pride in Uleth students" when they shouted me down (see attached).

Finally, Mr. Nathan Crow started a petition that resulted in putting pressure on President Mahon to cancel my talk (https://www.change.org/p/oppose-frances-widdowson-s-public-lecture-on-the-positives-of-indian-residential-schools). Mr. Crow mistakenly thought that I was giving a lecture on the residential schools, and believed that stopping me from speaking would ensure that the "correct" position could be disseminated to University of Lethbridge students. Crow also stated the following with respect to the violation of freedom of expression rights of Pickle, Viminitz, and me: "I support the notion of freedom of expression, but when that happens to discriminate a specific demographic of Ulethbridge students [sic], as well as support misinformation and false narratives, this is not okay" (see attached).

Thank you for considering this matter. I hope that you will agree to encourage critical thinking and help us to better understand the nature of academic freedom by participating in this event.






























Oppose Frances Widdowson's Public Lecture on the "Positives" of Indian Residential Schools

The atrocities that occurred within the Indian Residential Schoolsystem are 100% accurate and true, and I strongly feel that Frances Widdowson's attendance on our campus devalues the opinions and shared histories of the many survivors who attended this colonial system. This issue not only affects the many survivors that attended the IRS, but it also affects the children and grandchildren of these survivors who are dealing with the impacts of intergenerational trauma, like myself and many other students who attend our university.

The ULethbridge student population not only consists of many Indigenous students, but it also consists of many international students who do not know the harsh and accurate history of the Indian Residential School system.
